Supervisor Glaser called the meeting to order at 6:00PM with the Pledge to the flag.

Henderson Recreation Commission representatives Michelle Lawrence, Kathy Sidmore and Tina Spencer came and updated Board on current and past programs. Requested to do some grant writing on improvements at the recreation area and inquired about some new updated equipment. Expressed concerns on some areas that are deteriorating ex. Tennis courts, playground equipment and benches. Some funds are in those areas of the budget already and any additional funds through grants or other outside programs can only help. Board suggested to have group concentrate on one area and we can work towards helping that be improved and then move on to next. Several suggestions are on the table for the tennis court area.

Budget was reviewed by Board and some changes were made. Agree to move forward with preliminary budget and as a couple of numbers Budget director is waiting on come in Budget can be adjusted in time to adopt in November.

PILOT agreement with Military Rd. solar was reviewed again with no issues from any Board members.

#### PILOT AGREEMENT WITH MILITARY ROAD SOLAR, LLC

Resolved to accept resolution as follows:

**WHEREAS,** on or around January 2020, Military Road Solar LLC (the "Company") gave notice to the Town of Henderson (the "Town") of its intent to construct a solar energy system in the Town to be located at 13018 Cedar Vale Road (the "Project Site"); and

**WHEREAS,** in accordance with Real Property Tax Law 487(9), the Town informed the Company of its intent to require a PILOT; and

**WHEREAS**, the Company applied for site plan and special use permit approval pursuant to Chapter 150 of the Town Code for a 5 MW solar array to be developed on the Project Site; and

**WHEREAS,** under Chapter 150 of the Town Code, the proposed solar array is classified as a "large scale solar energy system" which is a permitted use on the Project Site subject to site plan approval and a special use permit from the Town of Henderson Planning Board (the "Planning Board") and compliance with the approval standards for large scale solar energy systems set forth in Section 150-62(G) of the Town Code; and

**WHEREAS**, the Planning Board conducted an environmental review of the application, and with the assistance of its technical and legal consultants, engaged in a detailed review of the application materials; and

**WHEREAS**, on November 4, 2020, the Planning Board as the lead agency under the State Environmental Quality Review Act ("SEQRA") adopted a Negative Declaration on the application concluding that the proposed subdivision and solar project will not create any potentially significant adverse environmental impacts; and

**WHEREAS**, the Planning Board approved the site plan for the solar project and granted a special use permit to the Company; and

**WHEREAS**, the Town and Company desire to enter into the PILOT agreement, attached to this resolution as Exhibit A, for the solar improvements to be located on the Project Site subject to the terms and conditions set forth therein; and

**WHEREAS,** the PILOT schedule for the solar project adheres to RPTL § 487(9)(b).

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board hereby approves the form and amount of the PILOT Agreement, attached to this resolution as Exhibit A, and hereby authorizes the Town Supervisor to execute the same; and

**BE IT FURTHER RESOLVED**, that this resolution shall become effective immediately:
