- Check appropriate column to indicate the anticipated size of the impact.
- Proposed projects that would exceed a numeric threshold contained in a question should result in the reviewing agency checking the box “Moderate to large impact may occur.”
- The reviewer is not expected to be an expert in environmental analysis.
- If you are not sure or undecided about the size of an impact, it may help to review the sub-questions for the general question and consult the workbook.
- When answering a question consider all components of the proposed activity, that is, the “whole action”.
- Consider the possibility for long-term and cumulative impacts as well as direct impacts.
- Answer the question in a reasonable manner considering the scale and context of the project.

Negative Declaration (SEQR) Sun Association Island RV, LLC/ Sun Communities Inc. Planned Development District for a campground on Hoveys Island

WHEREAS, the Town Board for the Town of Henderson is vested with the authority to process an application and render a determination for a Planned Development District ("PDD") submitted to the Town Board and Planning Board by Sun Communities, Inc. for a campground with related amenities (the "Project") to be located on Hoveys Island; and

WHEREAS, all potential involved agencies related to the Project are identified on the Full EAF Part I prepared by the Applicant/Developer and submitted to the Board; and;

WHEREAS, at a regular meeting of this Town Board held on September 12, 2023, the Town Board recommended that a SEQR Type 1 Action – Coordinated Review be conducted with the Town Board of Henderson serving as Lead Agency and to do so it sought consent from all other Involved Agencies and the Town Board has been established as the Lead Agency.

WHEREAS, the Town Board has duly considered the Project, the full EAF, the criteria for determining significance set forth in 6 NYCRR §617.7(c), consulted, and met with representatives for the Applicant, reviewed and considered the Environmental Assessment Report with full Appendix submitted by Colliers Engineering and Design on behalf of the Applicant, considered public comments provided during the extended public hearing interval, consulted with the Town's Engineers, consulted with the Town's Attorneys, familiarized themselves with the subject property and the neighborhood, and such other and further information as deemed appropriate by Board Members; and

WHEREAS, the Town Board has identified the relevant areas of potential environmental concern, has taken a hard look at these areas and has made a reasoned elaboration of the basis for its determination.

NOW, THEREFORE IT IS resolved that:

1. The above recitations are incorporated herein and made a part hereof as if set forth hereafter.
