Town Board members were provided with a copy of the monthly revenues and appropriations report.

Town Attorney Jim Burrows spoke about how Planning Board members invited him to meet concerning a proposed large scale solar project going on Gilman Rd. and Route 3 that a bunch of residents are concerned with. They asked about having a moratorium for 6 months for solar energy systems. This would put any applications or stop them form being submitted to Planning Board , Zoning Board of Appeals, and Town Board. The proposed project is just that, it is an incomplete application so nothing further would be able to happen with it if the moratorium is approved. A motion to set the date for a Public Hearing to discuss a possible moratorium on large scale / solar energy systems was made.

Motion to hold a Public Hearing on November 28, 2023 at 7:00PM at Town Offices located at 12105 Town Barn Rd., Henderson, New York to discuss a six (6) month moratorium on Solar Energy Systems/ Large Scale Solar projects.

Sun Communities Development project of Hovey Island update was provided by Attorney Jim Burrows . He discussed the process of SEQR, what the next sets are to take and the engineering reports that are available to be reviewed with Town Engineers, GYMO, that are available for the Town Board members to sit down with them and review so they can explain the actual information in the reports if the members have questions.

Preliminary 2024 Budget changes were discussed and accepted by Board.

### MOTION <u>2024 BUDGET</u> On a motion by Councilman Hall, second by Councilwoman Owen the following motion was

ADOPTED Ayes 4 Glaser, Flagg, Owen, Hall Nays 0 Motion to approve and enact the 2024 Annual Budget at a Town tax rate of \$.086 per thousand of assessed value and a Library tax rate of \$.0148 per thousand of assessed value keeping the Town under the 2% Tax Cap.

The Fireman and First responders tax exemption has been passed by the Jefferson County Board of Legislatures. The Town Board discussed possibly mirroring this exemption. The Fire Departments would audit all personnel each year that would be illegible for the exemption. Board will review and act at next month's Town Board meeting. If approved this will affect the 2025 tax season and would have to have all exemptions in by March 1, 2024.

Mooring administrator Jim Weber would like the Board's approval to email out the mooring renewals this year instead of using the US post office. The idea was discussed with all parties involved and seem to be in favor of this process. The Town Board has no problems with the mooring renewals being handled in this fashion.

Bass Tournament for Good Ole Boys was requested by Town Clerk, Wendy Flagg. Councilman Owen had pictures from a September 2023 catch and release tournament that showed several dead and slow-moving fish. He expressed concern with allowing such tournaments and doing this in the area to the fishing industry. He spoke with the fishing collation representative, and they expressed concerns with such tournaments and would like to see some type of control or monitoring. The Board agreed to hold off approving such tournaments until more information could be gathered.

Town Clerk asked Board for permission to amend the minutes from September 12, 2023 Board meeting in reference to Resolution # 2023-09-12-044. The wrong resolution was inserted in the test of the minutes. Board allowed Clerk to make the amendment as it was a clerical issue.
