Supervisor Glaser asks Board if there are any questions or concerns on proposed 2023 budget

Councilman Owen questions why a line or account was developed for Snowshoe Rd. He understands that the road may need repair but is confused why it is singled out and just not in with the rest of the roads.

Supervisor Glaser explains that the cost to repair that road will be very expensive and to start a line item and start earmarking funds towards the project will help reach those goals sooner.

Motion to approve and enact the 2023 Annual Budget at a Town tax rate of \$.086 per thousand of assessed value and a Library tax rate of \$.014911per thousand of assessed value.

Pat Scordo from GYMO engineering discussed water and sewer updates. Water District # 1 & 2 have submitted the health report to Department of Health and are waiting to hear if they will endorse us for a water tower expansion.

Sewer District #1 submitted design drawings and waiting to hear from Dept of Health, Dept of Transportation and Dept of Environmental Conservation. Next step are easements and figuring out EDU's. Easements are in process need to decide to mail or to hold walk in meetings.

WIIA Grant of 3.9 million awarded for project waiting on other two still.

Martin Clark of 13025 Cty. Rte. 123 approached and asked why him, and his neighbor were left out of the sewer district?

Pat Scordo asked Mr. Clark to show on the map their location and Mr. Scordo assured him it was not done on purpose and several others have been asking to be included and it will be determined how to get them included and he and Mr. & Mrs. Walty, Mr. Clark's neighbors would be included.

Sun Communities representative Erik Gothberg, VP Resort Development, presented a concept modifying the previous concept concerning Hovey Island. Sun Communities understands the concerns of the neighboring residents and hopes this new concept works towards a solution acceptable to all. This new concept reduces the density by 28%, eliminates new RV traffic by using 400 Sq. Ft. Park models similar to a small cabin. This will help reduce the development area by utilizing the existing barriers along the waterfront and wetlands as 75' and 100' setbacks will be used through the island with walking trails, central recreation area and kayak launch are a few areas to be established. No large marina will be built as the existing marina on Association Island can be utilized. A sun set viewing area was also discussed, this area may be turned over to the Town for all to use.

Councilman Owen asked what the Town would have to give in order for this to happen? Its open to discussion was response. This is a tricky area when it comes to insurance and maintenance issues.

Board thanked Sun Communities for new concept plan and askes for time to review and will be in touch if they have questions.

Gregory Scott of 8838 NYS Rte. 178, expressed concerns of drainage along State Route 178 as well as County Route 123 and suggested a drainage District be formed to obtain grants to fix the aging and failing system. There seems to be some issue with the Town saying they are not responsible and the State of New York saying they are not responsible to fix the issues along State Route 178 that are causing property damage and the possibility of somebody getting hurt with collapsing drainage tiles and grates. The drainage in the Harbor along County Route 123 has been anon going issue for some time and hopefully with the sewer district going in at both areas the issues will be addressed. As of the State Route 178 issues Supervisor Glaser will be in touch with the State Dept of Transportation to address who 's jurisdiction this is or if it could be handled together.

Zoning Committee working on Island District zoning, site plan and special use permits update, the group meet on October 18th and discussed language and definitions for

allowable items in Island District according to Schedule II permitted uses. Discussion of allowable uses of for Island District were reviewed and recommendations of changes made. Group will meet again in November 15th.

Planning Board vacancy still needs to be filled. Two applicants have sent in letters of interest. Board will set up interviews with each and choose candidate.

Lee Cagwin, Board of Assessment Review member and Ned Martelle, Planning Board member submitted letters of interest to continue on each respective Board for another term

Currently in Jefferson County only four towns/ villages/ cities are using online meetings and several that had been have discontinued, commented Supervisor Glaser.

<u>PUBLIC COMMENTS:</u> David Poulin asked if the Town was looking at reviewing development vs. growth and expansion in the whole town. Supervisor Glaser explained that the Town was working on a grant to help redo the 20-year-old Comprehensive Plan that we currently have.
