Town Board members were provided with a copy of the monthly revenues and appropriations report.

Sewer update by Pat Scordo we got the funding needed to complete the Sewer project. The BIL grant we have been waiting for was awarded at the end of the week, the Town of Henderson received \$11 million. That gives the project about 82% grant funding giving us \$23 million in grants out of a \$28 million project. The annual cost will be \$693 for the average single-family house and under the New York State Comptrollers threshold. Over the next three months the Town will be working on bond resolutions, district formations and finalizing easements. We hope to advertise the project for bids in December and open bids in January with construction beginning in March.

Coleman Mc Guane commented that some residents have said "no" to signing their easements. Pat Scordo said you should refer to the flow chart that shows they still have to pay the capital cost, obtain an engineer approved letter showing that their septic system is in compliance or eminent domain.

In Sewer District #2 the Town will be looking to become Lead agent for SEQR, approve the cost to have Tim Able begin archaeological study and looking for volunteer to have septic systems dye tested
