Town Board members were provided with a copy of the monthly revenues and appropriations report.

Sewer update we have been a year trying to secure easements. EFC has directed us to focus on the critical easements and keep working on the others. We will put a list of critical and semi-critical easements and concentrate on them.

The triathlon date has been rescheduled to June 22^{nd} if the Board is in agreement. The board approves the date of June 22^{nd} and feels it is much better than the original request of July 6^{th} which would fall on holiday weekend.

Attorney Burrows explains to the Board the process and what the Fireman's and First responder's exemption would consist of. It would be a Local Law if adopted offering a 10% reduction in the assessed value of such primary residential property for a member serving five continuous years with the same department. A Public Hearing must be set and then the Board may act on the law after that time.

Attorney Jim Burrows also told the Board the 6-month moratorium on large scale Solar systems was filed and in effect as of December 5, 2023. Board Should begin reviewing the changes to the zoning laws if any that they may want to review and change.
